Information regarding

DE-REGISTRATION ("EXMATRIKULATION")

Upon withdrawal and de-registration ("Exmatrikulation"), a student irrevocably leaves the university, e.g. after completion of his or her studies or when transferring to another university.

Deadlines: It is possible to withdraw at any time during an on-going semester. Subject to the provisions listed further below, students can withdraw with retroactive effect, i.e. withdrawal is possible with effect for the preceding summer semester by 31st October and by 30th April with effect for the preceding winter semester.

After these dates it is no longer possible to withdraw with effect for a preceding semester.

If a student has already re-enrolled for a subsequent semester and then withdraws by 30th September for the summer semester, or by 31st March for the winter semester, the study fees already paid for the subsequent semester will be reimbursed in full, reduced by any charges for late re-enrolment, if applicable.

If a student applies for withdrawal during the period 1st-31st October for the preceding summer semester, or during the period 1st-30th April for the preceding winter semester, any study fees that have already been paid for the subsequent semester can only be reimbursed if the student's Goethe Card has not yet been validated for the subsequent semester and if it is submitted. Such reimbursement will be reduced by an administrative fee of €50 pursuant to § 56 of the University Act of the State of Hesse ("Hessisches Hochschulgesetz") and, if applicable, by charges for late re-enrolment.

If the Goethe Card has already been validated or if it is not submitted, there is no claim for reimbursement! Therefore we recommend you validate the Goethe Card for any subsequent semester only once you are certain to continue your studies at the Goethe University in the respective semester.

Procedure: You can download the form from http://www.uni-frankfurt.de/35793976/a-rueckzahlung.pdf or get it from the Studien-Service-Center. Please fill in the original and the copy and sign and send **both** to the Studien-Service-Center / Students Office ("Studierendensekretariat"). You will then receive proof of deregistration, as well as documentation concerning pension claims, by mail. You can also hand in your application in person at the Students Office.

Documents: If you have already re-enrolled for the subsequent semester, you must submit your master data sheet (computer print-out including all academic transcripts) and the Goethe Card.
